4b (Code: ) (Expenses \$ 3,649,502 including grants of \$ ) (Revenue \$ ) Education and Outreach Program When a harmful exposure is identified,we follow the precautionary principle and immediately eeducate the public regarding strategies to avoid these exposures through publication of informative and well referenced articles. These are distributed through social media, electronic newsletters (Kennedy News & Views), and on our website.Once these exposures are identified we utilize health informatics data to further assess exposures to these chemicals and adverse health outcomes. If our finding support a causal relationship between the exposure and adverse health outcomes we identify potential sources of these exposures, those responsible for the exposures and work with them to reduce and eliminate.
